CONTRACTED SERVICE CONFIRMATION OF THE STANDARD BUNDLED UNIT LEASE

This Contracted Service Confirmation ("Confirmation") includes all of the conditions specified in the applicable Gas Storage Agreement ("Agreement") between the companies: **Podzemno skladište plina d.o.o.** Veslačka 2–4, 10000 Zagreb, OIB: 82292688592, (hereinafter: Operator) and [name, address and ident. No.] (hereinafter: User).

On the day this Confirmation is signed by both Parties the Confirmation will be enclosed with the Agreement [Agreement number] which the Contracting Parties have signed on the date [signature date] and will become its integral part.

The User states and guarantees that on the day this Confirmation is signed and during the term of this service:

- he possesses all of the authorizations, permissions and necessary licenses to perform the energy activity during the term of service on the basis of which he achieves his right to access the Gas Storage System.
- that the means of payment security, which the User will hand over to the Operator pursuant to this Confirmation, are valid and will be renewed if the need arises and that no third party does not have nor will have any reason to contest it, or does not contest nor will contest their validity and recoverability respectively.

Calculation of working volume fill up level (WV_{SBU}) and the associated withdrawal capacity ($Q_{WITH,SBU}$) are based on the rounded % value. Because of the rounding there are possible differences in relation to the reported absolute values listed in the table.

Hourly injection capacity ($Q_{INJ,SBU}/h$) or hourly withdrawal capacity ($Q_{WITH,SBU}/h$) represents 1/24 of daily capacity and is calculated in the following way:

By signing this Confirmation, the User agrees to the duration of the Agreement at the request of the Operator, in order to assess creditworthiness, submit the necessary financial statements not older than one month. In case of activation of Art. 9.9. of General Conditions for using the storage system, User shall submit, in the requested period, to the Operator additional provisions for security of payment.

Aside from the regular communication from Article 10 of the Gas Storage Agreement, additional operational communication between the Contracting Parties, and especially the communication from 16:00 o'clock of any day until 08:00 o'clock the following working day, as well as the operational communication during a crisis and other extraordinary circumstances will be conducted through:
